NOMINATING COMMITTEE MINUTES – SEPTEMBER 15, 2016

#### **CALL TO ORDER**

Committee Chair Diamond opened the meeting at 5:35 PM.

#### **PUBLIC COMMENT**

### **ACTION ITEMS**

<u>May 18, 2016 Meeting Minutes</u> – Mr. Welch made a motion, seconded by Ms. Long to approve the minutes. Motion passed unanimously.

<u>Transit Riders Advisory Committee Nominations</u> - Bob Lasher, External Affairs Officer, noted that there are six vacant seats on the TRAC and outlined the recommended applicants. He reported that PSTA received a total of 31 applications from all over the County. He said staff met and reviewed the applications and is requesting that the Committee recommend approval to appoint these six riders to the Committee:

After Mr. Lasher provided a brief bio on each applicant, Ms. Long made a motion, seconded by Mr. Welch to recommend approval of the TRAC nominations. There were no public comments. Motion passed unanimously.

<u>Nominating Committee Appointments</u> – Mr. Miller talked about the fact that staff is anticipating two vacancies on the Nominating Committee. He noted that it is imperative that there is a quorum for a much needed meeting in November to nominate Board Officers for 2017. Mr. Miller indicated that staff reached out to the Board and Ms. Gerard and Mr. Barkley expressed interest in serving on the Nominating Committee.

Ms. Long made a motion, seconded by Mr. Welch to nominate Ms. Gerard and Mr. Barkley to serve on the Nominating Committee. There were no public comments. Motion passed unanimously.
